Invitation

Planning is well under way for Bay Days 2014 and we would like to invite you to participate. We invite craft persons whose unique handmade crafts will be displayed for retail. In addition, Bay Days '14 will also feature information and retail booths.

Applications for Bay Days '14 are due by **June 13.** Vendors will be notified via e-mail if they are not accepted or there is no space available.

In order to provide the best festival atmosphere, vendors will be selected based on three criteria—unique products, booth appearance, and application postmark. If all things are equal, the first applicant will be granted space. Be sure to submit a photo of your booth with your application.

Please note that booth space is limited. Submit your application early. We look forward to your participation!

Eligibility

- Arts & Crafts: products that are handmade crafts by the vendor; paintings, sculptures, pottery, and photography (no food or drink sales allowed).
- Information: non-profit organizations, educational institutions, clubs and civic groups (no food or drink sales allowed).
- Retail: commercial business/retail sales.
 Products that are not handmade by the vendor. (no food or drink sales allowed).

Festival Rules

- The basic vendor fee is due with the festival application. An invoice will be sent to those requesting additional booth space footage.
- No spaces will be assigned or held without payment. If you are not accepted into the festival, payment will be returned to you.
- Registration fees will not be refunded due to undesirable weather.
- Set up for the festival at the following times: Fri., July 18, from 10am-2pm; Sat., July 19, from 7am-9am (5K & 10K will be running on the sidewalk); and Sun., July 20, 7am-9am. (the Chequamegon Bay Sprint Triathlon will be running on the sidewalk) Setup will not be allowed before or after these designated times.
- Vendors setting up on Friday may sell until 10pm Friday night.
- Vendors can dismantle their booths between 3pm-6pm on Sunday, July, 20.
- Bay Days is an outdoor event. Vendors are responsible for providing their own tables, chairs etc.
- No Food or Beverage for sale by arts & crafts vendors, retail vendors, or information booths. For food vendor information, contact: 715-682-2500.
- Electricity will not be available to craft vendors.
- Vendors interested in booth space during Maxwell Street Days must complete a separate application.

Festival Rules Cont.

- The vendor is entirely responsible for the leased space and shall keep it free from any conditions which might be dangerous. For safety reasons, no cooking will be permitted outside the designated booth space.
- Booth clean-up and garbage removal is the responsibility of the vendor during and after the festival. A \$50 fine will be levied against any vendor who does not remove their garbage during and after the festival.
- No vendor or representative shall conduct him/herself in a manner offensive to standards of decency or good taste.

Cancellation Policy:

If you cancel by May 30, you will receive a 75% refund. After May 30, no refund.
